3) AIMS AND OBJECTS:-


To run institutional classes for the benefit

- xiv) To constantly carry out research in education to enhance the quality and method of teaching so that our system of education improves.
- xv) All income of the society shall be utilised for the promotion of the above aims and objectives.
- xvi) To provide scholarships to people for specialized education in India and overseas.



1) NAME

: The name of the Society shall
be THE CHRISTIAN EDUCATIONAL
SOCIETY.

2 a) MEMBERSHIP

: Subject to the approval of the
society governing body any
Christian may become a member
of the Society provided he/she
believes in the aims and objecti-
ves of the Society.

: The governing body of the Society
may refuse any person membership
provided reasons for the refusal shall
be communicated to the person concerned


: The governing body of the Society may
expel any member from the Society on
the following grounds:-

: If the member fails to pay the monthly
subscription continuously for three months
from the due date of paying the subscrip-
tion.

The reasons for expulsion shall be communicated to every member. Every such expelled member shall have a right to appeal before the general body which may or may not be accepted.

4) GENERAL BODY : There shall be a general body of the Society consisting of all members. The meetings of the general body shall be held after every one year, with 1/3 Quorum. No quorum shall be required in the adjourned meetings. In emergent meeting of the general body may also be summoned on the written request of 3/5 members. Following business shall be transacted in these meetings:-

- a) To prepare annual programmes and policies.
- b) To fix the budget of the Society.
- c) To decide all such matters and issues which directly related to the affairs of the Society.
- d) To appoint auditor or who will annually inspect the accounts and funds.

5) GOVERNING BODY : There shall be a governing body of the Society to look after and to manage the day to day affairs of the Society. It shall consist of minimum 7 and maximum 12 members including the office bearers. The meetings of the governing body shall be held after every one month with 1/3 quorum. No quorum shall be required in the adjourned meeting. In emergent meeting of the governing body may also be summoned on the written request of 3/5 members. Following business shall be transacted in these meetings:-

- a) To take necessary steps for the implementation of all the programmes and policies drawn by the general body.
- b) To pass the necessary expenditure to meet the day to day requirements of the Society.
- c) To take all such other legal steps which may appear beneficial for the smooth and better management of the Society.

- 12). LOCAL PROCEEDINGS: The society may sue or be sued in the name of its President as required under section 6 of S.R. Act, of 1860.
- 13). Any amendment in the Memorandum or Rules of this Society shall be carried out in accordance with procedure laid down in S.R. Act of 1860.
- 14). This society may be dissolved in accordance with procedure laid down under sections 13 and 14 of S.R. Act of 1860.

All the provisions of S.R. Act of 1960 (Punjab Amendment Act of 1957) as extended to Union Territory of Delhi shall apply to this society.
